



Primary (Ob/Gyn) Written Application Details Examination Spring 2018

Applications Available: September 1, 2017 – February 26, 2018

Applications submitted September 1, 2017 – February 19, 2018 require the standard fee (\$1175) which will be included upon submission of the application.

Applications submitted February 20-26, 2018 require an additional late fee (\$250) which will be included upon submission of the application.

Examination Date: April 23-28, 2018

Location: The Primary Written Exam is now being offered at computer-based testing centers across the U.S. Once your application has been approved and you are able to sign up for a testing location, we will send you the information you need to sign up for a date, time, and location near you.

Please note that this exam is no longer offered in conjunction with the Spring Oral Exams in Rosemont, IL.

All information about this examination is located in the AOBOG Library. Access the Library from your user account; click Calendar/Library; click Title in the Library header; refer to articles for Primary Written.

Be sure to read this entire application and referable Library articles. Applicants are responsible to be informed about all information and instructions.

Prerequisites

NOTICE: Physicians certified in Obstetrics and Gynecology by the ABMS who have been approved by the AOA through Resolution 56 are exempt from this examination.

Review the information that you have entered into your AOBOG user account under “My Profile” before submitting this application. Basic Info, Contacts (addresses), Training, and Licensing must reflect complete, current information.

Prerequisites to sit for this examination DURING residency training

Applicants Must:

1. Have graduated from an AOA-accredited medical college.
2. Have completed a minimum of 2 years of OB/GYN residency training in an AOA-approved training program (osteopathic or allopathic).
3. Be a current member in good standing of the AOA or Canadian Osteopathic Association.

4. Request a letter from their program director verifying their residency status, and have this submitted to the AOBOG by the final deadline.

- The AOBOG must receive the verification of the applicant's residency status by the application deadline date in order to confirm that the candidate meets the above prerequisite requirement.

5. Have submitted the application by the deadline date.

6. Have been notified of acceptance for examination. (See Notifications section.)

Prerequisites to sit for this examination AFTER residency training
Applicants Must:

1. Have graduated from an AOA-accredited medical college.
2. Have completed an AOA-approved OB/GYN residency program (osteopathic or allopathic).
3. Be a current member in good standing of the AOA or Canadian Osteopathic Association.
4. Have submitted a copy of their residency certificate to the AOBOG via mail, email, or fax (contact information above). The document must be received by the application deadline.
5. Have submitted the application by the deadline date.
6. Have been notified of acceptance for examination. (See Notifications section.)

Primary OB/GYN Written Examination and Study Topics

The AOBG does not endorse, recommend, or provide any information about review or preparation courses for this examination.

The written examination is the first of two examinations in the primary certification process. It is offered on an annual basis.

The examination is a 4 hour objective examination consisting of 225 multiple-choice questions which are representative of the practice of a primary OB/GYN physician. The test blueprint for the examination is:

Topic	Percentage of Questions on Exam (range)
Gynecology	39-43%
Reproductive Endocrinology and Infertility	7-11%
Female Pelvic Medicine and Reconstructive Surgery	6-10%
Gynecologic Oncology	4-8%
Obstetrics and Maternal Fetal Medicine	34-38%

Topics which may be included on the examination are provided as a guideline for study, and are found below (page 5). A list of major references used for the examination are also provided as a study aid below (pages 6-7).

Examinations are electronically scored and psychometrically evaluated. The criterion referenced standard setting method is utilized to determine the cut score (pass/fail mark) prior to administration of the examination. Examinations are not graded on a curve.

NOTE: ABMS-certified physicians who have been approved by the AOA to enter the certification process via Resolution 56 are exempt from this examination.
