



## Primary (Ob/Gyn) OCC Component 3 Application Details Cognitive Assessment Examination Fall 2018

Applications Available: March 1 – August 13, 2018

Applications submitted March 1 – July 30, 2018 require the standard fee (\$1525) which will be included upon submission of the application.

Applications submitted July 31 – August 13, 2018 require an additional late fee (\$250) which will be included upon submission of the application.

### Examination Dates: September 24-29, 2018

Location: The Primary OCC Exam is now being offered at computer-based testing centers across the U.S. Once your application has been approved, and you are able to sign up for a testing location, we will send you the information you need to sign up for a date, time, and location near you.)

**Please note that this exam is no longer offered at the ACOOG Annual Conference.**

All information about this examination is located in the AOBOG Library. Access the Library from your user account; click Calendar/Library; click Title in the Library header; refer to articles for Primary OCC.

**Be sure to read this entire application and referable Library articles. Applicants are responsible to be informed about all information and instructions.**

### Prerequisites

**Review the information that you have entered into your AOBOG user account under “My Profile” before submitting this application. Basic Info, Contacts (addresses), Training, and Licensing must reflect complete, current information.**

#### Applicants Must:

1. Have received certification in Obstetrics and Gynecology from the AOA.
2. Be a current member in good standing of the AOA or the Canadian Osteopathic Association.
3. Hold a valid, active license to practice medicine in one of the 50 states or Canada.
4. Exhibit conformity to the standards as set forth in the Code of Ethics of the AOA.
5. Have submitted the application by the deadline date.
6. Have been notified of acceptance for examination. (See Notifications section.)

### Primary OCC Component 3 Examination Details and Reference Sources

The Primary OCC Exam will consist of 100 multiple-choice questions over 2 hours. The test blueprint for the exam is:

Obstetrics	35 - 45%
Gynecology	55 - 65%

Wherever possible, questions will be referenced from the resources listed below, thus directing the examinee toward an evidence-based document to assist in preparation for this examination. Note that these reference sources cannot be entirely comprehensive of all areas of OB/GYN practice. General knowledge reflective of the current standard of care based on the best available medical evidence is expected. Emphasis is placed on important changes in treatment guidelines (where applicable).

#### Reference Information

The primary reference source for the OCC 2018 examinations will be the 2017 edition of **ACOG *Compendium of Selected Publications***, which is a compilation of selected ACOG current clinical practice guidelines.

This publication includes:

- **Practice Bulletins:** Practice Bulletins summarize current information on techniques of obstetrics and gynecology. Practice Bulletins are evidence-based documents, and recommendations are based on the evidence. Evidence is graded and peer-reviewed.
- **Committee Opinions:** Committee Opinions represent an ACOG committee's assessment of emerging issues in obstetric and gynecologic practice and are reviewed regularly for accuracy.
- **Technology Assessments:** Technology Assessments are documents that describe specific technologies and their application.
